The report is used as part of quality control processes by detailing the problem, how it occurred, and how to prevent it from happening again.

Once a problem has been identified through inspection, customer complaints, or audit results, it should be captured using non-conformity reports (NCRs) or corrective action reports (CARs) in order to identify who is affected by the problem and what the impact is.

## 10.2 Non-Conformity & Corrective Action

Quality engineer is responsible for maintaining the non conformity records and follow up the corrective actions. He prepares monthly report of NCR's/CAR's highlighting the most occurring root cause, and sends the same to quality manager for further analysis and decision making. A NCR or CAR register is maintained for each project.
